Proposed amendments from general members should be submitted directly to the Regional Director.

After approval by the chapter, proposed amendments must be sent to the Regional Director and the region's representative to the International Constitution Committee for consideration by the regional conference.

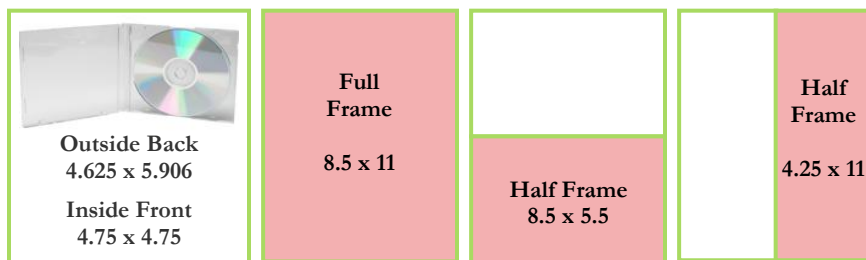
